Amendments to the JETS Workforce competencies

From **Thursday 27 April** the JETS Workforce team will be implementing changes to the competencies. We have streamlined the requirements of the competencies as well as the processes. The changes have been made to all levels of the programme, including the evidence requirements. These changes have been made following feedback we've received from users on the framework.

Most of the changes have been made to the level one foundation of the competencies, with some changes also being made to level two and three. To review the full list of changes, visit our <u>competencies page</u> which provides a full list of the old and new competency framework.

Who will remain on version 1 (original) of the competencies?

All users that have been working on their competencies for the last **8 months**, including those that have added any evidence, will remain on the current competencies. If you remain on the current competencies, you will have until **27 April 2024** to complete them. After this date the competencies will be archived, and you will automatically be moved to the new competencies.

Who will be moved to version 2 (updated) of the competencies?

Anyone who has been inactive on their competencies page and not created any evidence in the last **8 months** will be moved to the new competencies.

You will remain on the existing competencies. You will be moved to the new competencies.

Users who remain on the <u>current competencies</u> will have until <u>12</u> <u>April 2024</u> to complete the competencies. After this date all the old competencies will be archived.

Can I move to the new competencies if I want to?

Yes, you can move to the new competencies. The person who has unit manager access at your service will have the ability to amend your profile, in the section highlighted below. You can also opt to remain on the old competencies, however, please be aware that you will have until **27 April 2024** to complete the competencies.

What will happen to any evidence I have created?

Any evidence that you have submitted will remain in your evidence tab. However, witness statements from version 1 of the competencies **cannot** be used on the new iteration of the competencies. This is because we have now included a new piece of evidence, a reflective account (RA). Witness statements for version 1 of the standards included a reflective account, which has been separated from the witness statement.

If I've already completed the competencies, will I need to do them again on the new competences?

No, you will not need to complete the new competencies if you have already completed and been signed off on version 1.
